# **LIMITED 30 YEAR WARRANTY**

#### WHAT IS WARRANTED AND FOR HOW LONG?

International Insulation Products, LLC (IIP) warrants all Sol-R-Skin™ BLUE underlayment (Product) free from manufacturing defects when subject to normal and proper use and manufactured by IIP's product specifications for a period of thirty (30) years from the date of original installation. Liability under this warranty is limited, at IIP's discretion, to include replacement of defective Product without charge or, in the alternative, a refund of 100% of IIP's original selling price for only the quantity of the product deemed defective. In instances in which IIP determines that only a portion of the Product manifests a defect, IIP reserves the right to limit any replacement or refund to the portion of the Product that manifests the defect. Labor charges or other costs incurred with removal or installation of either the original or replacement Product are not covered by this warranty. In the event of replacement under the terms of this warranty, the original warranty shall apply to the replacement Product and will extend for the balance of the warranty period remaining at the time of replacement.

## WHO IS COVERED?

This warranty is granted solely to the original consumer purchaser or owner. It may not be transferred; provided that if you purchase a new residence or commercial building and are the first person to occupy the building, IIP will consider you to be the original purchaser if the Product was installed as part of the construction of that structure.

#### **LIMITATIONS**

IIP will not be liable for, and this warranty does not cover:

- Consequential or special damage of any kind, including (but not limited to) damage to the interior or exterior of any building or to any property contained in or near it.
- 2. Damage to the Product resulting from causes beyond normal wear and tear including (but not limited to):
  - a. Hailstorms or other unusually strong storms, high winds or acts of God.
  - b. Impact of foreign objects.
  - c. Traffic on the roof.
  - d. Improper handling, storage, or installation of the Product.
- 3. Replacement or failure of any products used on the roof that were not manufactured by IIP.

- 4. Damages to the roof resulting from anything other than an inherent manufacturing defect in the Product including (but not limited to):
  - a. Defects in, failure, or misapplication of material used as a roof base.
  - Application of solvents, paints, cleaning solutions or coatings.
  - Settlement or movement of the building, walls, foundation, or roof deck.
  - d. Inadequate roof drainage. No ponding water may be evident 48 hours after a rainfall.
  - e. Subsequent structural changes or alterations, including (but not limited to) installation of equipment on the roof or any other modification such as antennas, air conditioning equipment, skylights or solar collectors.
- 5. Any costs incurred for repair or replacement not authorized in writing by IIP.
- 6. Workmanship defects.
- Material not installed in strict compliance with the specifications and installation guidelines in force at the time.

## **HOW TO MAKE A CLAIM**

In the event you believe Sol-R-Skin™ BLUE fails to conform to this warranty, you must notify IIP in writing at: IIP Attn: Dermot Ennis 4938 S. Atlanta Road Suite 700 Atlanta GA 30339 or email Info@iiproducts.com. The claim must be made within thirty (30) days of the date the claimed defect was first discovered. Written notice must include a full description of the defect and a minimum of three pictures of the defective material. IIP may also require proof of property ownership. IIP may inspect the claimed defect, or, at its option, may require that a sample of the allegedly defective product be shipped to IIP headquarters. If IIP's review of the claim does disclose a defect covered by this warranty, IIP will perform its obligations under this warranty to the extent of the Product that actually manifests defects. IIP reserves the right to inspect the alleged defective material prior to its removal from the installation location, and the owner must provide IIP with reasonable access for such inspection, or IIP's obligations under this limited warranty shall terminate. IIP will not be liable for any actions or expenditures incurred prior to written confirmation of IIP's responsibility under this warranty.
